

MÉLANIE LA COUTURE IS APPOINTED CHIEF EXECUTIVE OFFICER OF THE OSM

A top-level executive to lead the Orchestra continue along its path of excellence, innovation and community involvement.

Montréal, May 22, 2024 – The Orchestre symphonique de Montréal (OSM) is proud to announce that Mélanie La Couture will be its next chief executive officer. Madam La Couture will succeed Madeleine Careau, who, as she announced in January, will be leaving her position at the end of next month after nearly 25 years of heading the OSM's administrative department.

The appointment of Mélanie La Couture, who will take up her duties at the beginning of July, is the result of an elaborate recruitment process undertaken by the board of directors after the announcement of Madam Careau's departure. The recruitment committee, created by the board and supported by an executive search firm, wishes to thank the many greatly talented people, from Canada as well as from abroad, who showed an interest in the position.

In the course of its work, the committee identified Mélanie La Couture as a potential candidate of the highest order for the position of chief executive officer, and persuaded her to consider the possibility of taking up the challenge. Thanks to her considerable experience as a manager, her demonstrated ability to bring people together, her extensive expertise in philanthropic development and her well-articulated vision with regard to the Orchestra's future, Madam La Couture stood out among the finalist candidates and clearly established herself as the best person for filling the CEO position. The recruitment committee's recommendation was unanimously adopted by the board of directors.

Trained at the École polytechnique de Montréal, and the holder of a master's degree in business administration (MBA) from the University of Western Ontario, Mélanie La Couture has played a key role at the Montreal Heart Institute since 2013, first as managing director of the cutting-edge institution's Foundation, and the last seven years as a member of the board of directors and as president and CEO of the Institute itself. Previously, she spent 11 years with the OSM, notably occupying the position of chief operating officer from 2007 to 2013. Earlier in her career, Mélanie La Couture worked as a management consultant for major international companies
